Personnel: 3 person-months effort per year (9-month basis) is assumed, at a \$10,000 per person-month and Fringe Benefits: 33.06% fringe benefit rate. Total Direct Costs: \$164,526 Indirect Costs (48.2% of total direct costs): \$79,302

The lead institution, University of Illinois at Urbana-Champaign (UIUC) budget breakdown is as follows:

1. Personnel

Partial salary support for faculty is requested. This support will be used to partially offset faculty effort on the project. Total Year 1 salary funds requested are \$2,450.

2. Fringe benefits

Per UIUC guidelines, the fringe benefit rate is computed as 33.06% of faculty salary which for UIUC equals \$810. Total Year 1 fringe benefit funds requested are \$810.

3. Travel

Funds are requested to pay for two UIUC faculty person to travel to the annual Project Director's meetings in the US in Year 1. Additionally, in Year 1 funds are requested for faculty at UIUC to travel to Brazil partner institutions and industry collaborators. These trips will allow our Consortium to participate in curriculum development, to continue to develop institutional frameworks for the collaboration, and to collaborate with Brazilian colleagues. A total of \$6,000 in Year 1 is requested, with \$2,000. for domestic and \$4,000. for foreign travel in the UIUC budget.

In Year 1, \$2,500 per year is allocated for an agency-required external evaluation of our program. This project's evaluation will be done by Prof. Conrad Heatwole of Virginia Tech University.

- C. Travel One PU partner to travel to the annual Project Director's meetings in the US in Year 1. Additionally, in Year 1 funds are requested for US faculty UIUC & PU) to travel to Brazil partner institutions and industry collaborators. These trips will allow our Consortium to participate in curriculum development, to continue to develop institutional frameworks for the collaboration, and to collaborate with Brazilian colleagues. A total of \$3,998. in Year 1 is requested for foreign travel in the sub-award travel budget.

In Year 1 of the UIUC budget \$5000. is specifically reserved for registration and conference expenses for hosting the 2009 U.S.-Brazil meeting in the United States. We understand that FIPSE will provide instructions on the disbursement of these funds. This amount may not be used for any other grant expenses. PU has no funds on this budget line.

8. Total Direct Costs

Total direct costs are calculated as the sum of personnel, fringe benefits, travel, supplies, contractual (evaluator payment) and other expenses (conference fees) for UIUC. In Year 1, this total is \$32,485.

9. Indirect Costs

Per instructions of the FIPSE RFA, an 8% indirect charge is allowable. Calculated on the MTDC funds of \$31,385. (not Total Direct Costs) the funds requested are \$2,511. No indirect costs are calculated on the contractual costs of the reviewer or the Mobility and Language Stipends. Nor was any indirect costs calculated on these exempt items by us in the PU sub-award. UIUC calculates indirect costs on the 1^{st} \$25,000. of a sub-award, so some of the funds from this calculation are included in Year 1 and Year 2 Total Indirect Cost.

10. Student Mobility

With respect to student mobility, we do not anticipate sending any students from UIUC in Year 1.

11. Student Language Training

In Year 1 \$1,100. is requested by UIUC to fund language training for up to four promising students in preparation for study abroad in the following years. If this is not expended in Year 1 it will be moved into budget Years 2, 3 and 4 in this category and the per student language training will be increased accordingly.

12. Total Request from FIPSE

Total request (total direct costs + indirect costs + student mobility and language training) in Year 1 is \$34,996.

The lead institution, University of Illinois at Urbana-Champaign (UIUC) budget breakdown is as follows:

1. Personnel

Partial salary support for faculty, equivalent to approximately 1 person-month per year, is requested (based on 9-month appointment). This support will be used to partially offset the faculty effort on the project, equating to about one week per co-PI per annum. Annual increases of 2% are assumed in subsequent years. Total Year 2 salary funds requested are \$5,500.

2. Fringe benefits

Per UIUC guidelines, the fringe benefit rate is computed as 33.06% of faculty salary which for UIUC equals \$1,818. Total Year 2 fringe benefit funds requested are \$1,818.

A total of \$6,000 in Year 2 is requested, with \$1,000. for domestic and \$5,000. for foreign travel in the UIUC budget.

Total direct costs are calculated as the sum of personnel, fringe benefits, travel, supplies, contractual (evaluator payment) and other expenses (conference fees) for UIUC. In Year 3, this total is \$73,761.

9. Indirect Costs

Per instructions of the FIPSE RFA, an 8% indirect charge is allowable. Calculated on the Year 3 MTDC funds of \$21,965. (not Total Direct Costs) the funds requested are \$1,757. No indirect costs are calculated on the contractual costs of the reviewer or the Mobility and Language Stipends. Nor was any indirect costs calculated on these exempt items by us in the PU sub-award.

10. Student Mobility

In Year 3, the UIUC requests \$16,000. for student mobility. We anticipate sending 4 students from UIUC in Year 3. The student mobility amount requested is \$4,000. per student, or \$16,000. in Year 3.

11. Student Language Training

In Year 3 the language stipend is anticipated to be for 4 students from UIUC. The language training is calculated at \$1,200./student, or \$4,800. in Year 3.

12. Total Request from FIPSE

Total request (total direct costs + indirect costs + student mobility and language training) in Year 3 is \$75,518.

The lead institution, University of Illinois at Urbana-Champaign (UIUC) budget breakdown is as follows:

1. Personnel

Partial salary support for faculty, equivalent to approximately 1 person-month per year, is requested (based on 9-month appointment). This support will be used to partially offset the faculty effort on the project, equating to about one week per co-PI per annum. Annual increases of 2% from Year 3 are assumed. Total Year 4 salary funds requested are \$5,722.

A total of \$5,108. in Year 4 is requested, with \$1,108. for domestic and \$4,000. for foreign travel in the UIUC budget.
